

ACTION REQUIRED
3. Authorization to apply for and if awarded accept the grant funds from the Victims Assistance Direct Services Program grant through the Office of the Governor. Resolution included. Approval of the District Attorney's office to apply for, and accept if awarded, grants for Victims Assistance Direct Services Program through the Victims of Crime Grant through the Criminal Justice Division of the Office of the Governor for the fiscal year 2020-2021. ACTION REQUIRED


