DISCUSSION ON DISPOSING OF
SOLID WASTE IN COUNTY
PRECINCT STATIONS

Chairman Guerra, proceeds with the Public Workshop on reference to the disposing of solid waste in County Precinct Stations. Commissioners Gonzales and Guerra are concern about the disposing of construction material being disposed in their Precincts. They mention some contractors are coming from Cameron and Hidalgo Counties disposing of their materials in their precincts. The Court would like to set a permit fee for disposing of solid waste. Also, the other concern is deciding the location, setting up a portable scale and being able to hire someone for monitoring the site.

The Court agrees on looking into the Recycle Center next to Precinct 3, to see if there would be enough room to place the disposing containers (dumpsters).

Motion was made by Commissioner Gonzales, seconded by Commissioner Guerra for approval to regroup at Precinct 3. Motion was put before the Court by the Chairman. Chairman Guerra, Commissioners Guerra and Gonzales voting AYE. NAYS NONE. Motion was declared carried.
