#### The selected Contractor shall meet the following requirements:

#### A. Pick-up and Turnaround Time.

- (i) Is responsible for the pick-up of the Willacy County documents for scanning, imaging, and indexing from designated Willacy County sites. Willacy County will be responsible for preparing the documents boxed prior to pick-up.
  - (ii) Work with Willacy County to mutually develop a procedure, as well as a pickup and delivery schedule.

#### B. Transportation of Documents.

(i) Transport all documents in closed, climate-controlled vehicles.

#### C. Tracking and Inventory of Documents.

- (i) Inventory and acknowledge the receipt of all items and maintain an automated tracking system, which allows for the retrieval of any document that is within the Contractor's control.
- (ii) Any discrepancies between Willacy County's departmental inventory transmittal and the items received by the Contractor are to be resolved within ten (10) calendar days.
- (iii) Upon completion of services and prior to returning records to Willacy County, perform a final quality control step. This quality control step should compare the final output to the manifest that Willacy County provided to the Contractor to ensure that every document has been digitized and indexed. The contractor shall provide a report to Willacy County, which compares the documents provided to the final output with each product delivery. Willacy County will work collaboratively with the Contractor regarding this step.

#### D. Preparation Requirements.

- (i) For documents to be scanned, the Contractor shall perform "Document Preparation" as necessary to scan all files. This includes removing all staples and paperclips, repairing all torn documents with non-reflective tape, straightening all folded plans, mounting any irregular size memorandum on standard  $8\frac{1}{2} \times 11$  or  $8\frac{1}{2} \times 14$  paper, and otherwise making the documents ready for processing.
  - (ii) If any ensure all Post-its or Sticky Notes on documents are captured in the scanning process.

#### E. Quality, Production, and Pricing.

- (i) Preserve all data in a form identical to, or functionally equal to, the original record.
- (ii) Provide a unique file name to each scanned image, which will be provided by Willacy County, and ensure all documents in each file are organized appropriately and pertain to the title of the file.
- (iii) Rotate documents to provide maximum readability (e.g. letter shall be displayed in proper orientation without needing to rotate before viewing).
  - (iv) Use 300 dpi or higher.

- (v) Do not scan blank documents.
- (vi) Perform a consistency check on 20% of the images to assess image clarity, orientation, and accuracy.
  - (vii) Ensure that the scanning system is free from dust and other particles.
- (viii) Report and discuss with Willacy County contact any problem images that cannot be captured to meet benchmark specifications.
  - (ix) Inspect archived blueprints/maps for quality and consistency.
  - (x) Post-process digital images (cropping, de-skewing, de-speckling, image rotation). (xi) If a document has more than one page, scan the document as a single file multi-page document.
  - (xii) Provide disaster recovery policy.
  - (xiii) Provide an alternative to access data or offline resources in the event of cancellation of services.
  - (xiv) Provide Willacy County the capability to upload existing electronic/PDF documents into the indexing system.
  - (xv) Provide disaster recovery policy.
- F. Confidentiality, Accuracy, and Security of Willacy County Documents.
  - (i) Maintain documents in safekeeping from the time of receipt and while in Contractor possession.
- (ii) Keep all documents confidential and secure, which includes using secure network practices and maintaining documents in a physical location that is secure and dry.
- (iii) Keep documents in an established business location that provides security and supervision. Willacy County requires safeguards against theft, loss, and/or damage to be maintained at the highest levels. The contractor will be held responsible and fined up to \$500 (per page) for lost, stolen, or damaged documents.
  - (iv) Prohibit the unauthorized reproduction or duplication of any Willacy County documents.

#### G. Record Accessibility

- (i) In the event a document is needed while in Contractor's possession, within one (1) business day of making a request, provide access to designated Willacy County Staff to original Willacy County documents supplied to the Contractor for Scanning/Digital Image and Indexing Conversion Services.
- (ii) Store scanned documents in Contractor's digital platform and accessible by multiple Willacy County employees/departments for the duration of the Agreement. Contractor to provide details and specifications as to how this will be handled.

(iii) Agree that all documents/data are the property of Willacy County and promptly return, upon completion of the work, or at Willacy County's request, all documents in substantially the same condition as when the documents were picked up.

Willacy County expects the following type of documents will need to be serviced:

- 1. Letter and Legal-size documents (Anticipated largest is 11" x 17")
- 2. Large Blueprints/Maps (potential quantity unknown)
- 3. Pictures

#### 4. Contract Award, Term, Contract Amount

The County anticipates that the initial duration of any contract resulting from this solicitation shall be for a period of **two (2) years.** The County, at its sole option, may extend any contract awarded pursuant to this solicitation for up to **one (1)** additional year.

Following the base term and any allowable extensions, The City/County may extend any resulting Contract for the purpose of completing a new procurement, and/or transitioning to a new vendor if necessary to avoid interruption in Willacy County services.

#### Contract Term

As a result of this RFP, The County reserves the right to award one Firm Fixed Price Contract. Interested parties may submit a request for a proposal by May 23, 2023. Questions are due for this RFP by May 17 2023.

Offeror(s) must be not debarred at the time of submission and complete the attached 'Non-Debarment Self Certification Form. Prior to award, the offeror must provide proof of registration, active/good standing and non-debarment status in the System for Award Management. SAM.gov will be checked prior to award of the contract. If an offeror is not registered with SAM.gov, or the offeror is debarred, then the offeror's proposal will not be evaluated.

#### 5. Contract Amount

The budget amount is optional; Willacy County reserves the right to negotiate with any vendor.

#### 6. No Guarantee of Volume, Usage or Compensation

The City/County makes no guarantee of volume, usage, or total compensation to be paid to any Respondent under any awarded Contract, if any, resulting from this Solicitation. Any awarded Contract is subject to appropriations and the continuing availability of funds.

#### 7. Governmental Entities

The selected respondent shall be bound to specific terms and conditions found in Part 200 of the Uniform Administrative Requirements, Cost Principles, and Audit Requirement for Federal Awards and Title 10, General Government; Subtitle F, State and Local Contracts and Funds Management; Chapter 2252.

#### 8. Other Applicable Conditions

In all contracts, recipients, vendors, contractors, and other applicable sources must specifically refer to the project or provide detailed information regarding the purchase or work being funded. In addition to other Federal and State provisions required, all contracts must address, if applicable, any contract provisions provided in Exhibit B. The Willacy County is seeking to enter into a general purchases and supplies contract with a SAMs registered vendor/supplier. The Willacy County has received an allocation of American Rescue Plan Act (ARPA) funds and desire to solicit bids in order to complete its ARPA programs and projects. The following are the required elements of this request for proposal. #### 1. Consideration of the Award

To be considered for the award, respondents must adhere to the requirements as set forth by in Part 200 of the Uniform Administrative Requirements, Cost Principles, and Audit Requirement for Federal Awards contained within this solicitation and provide all other required information and documentation as set forth in this solicitation.

The scope of work includes the qualified service provider will provide the following services:

- Scanning of records and Index Shuck case files to digital image electronic format for access and records retention; Placing in an acid-free folder; converting files into Case Management Software.
- Provide a solution for adding future files to indexing processes.
- Document scanning/digital image with indexing and proper orientation at a minimum of 300 dpi
- Indexing for conversion to digital based on an industry-standard Image File Format that
  accommodates large and standard-size documents at a minimum of 300 dots per inch and processes
  these digital images to be seamlessly included into Willacy County's current Financial Management
  System and document platform.
- Optical Character Recognition (OCR) Services. This process shall provide an accurate conversion of image data into a searchable PDF format.

Pricing for scanning/digital imaging services (large documents): Provide total price per image for scanning 8 ½ x 14 large/legal formatted documents. Provide total price per document for reassembly and return of documents during regularly scheduled pickup.

Pricing for travel: Provide a total price for pick-up and delivery charges.

#### 22. Other Information

The Willacy County may contact references provided in response to this Solicitation, contact respondent's client, or solicit information from any available source.

#### 23. Initial Compliance Screening

Willacy County will perform an initial screening of all solicitation responses received. Unsigned solicitation response and solicitation responses that do not meet the minimum qualifications above and/or do not include all required forms and information may be subject to rejection without further evaluation.

#### 24. Additional Evaluation Criteria

All solicitations will be evaluated based on Evaluation Criteria listed in #21 above. Responsiveness means adhering to the Terms and Conditions and specifications of the supplies requested. If an offeror(s) who has the lowest price is deemed to be non-responsive, Willacy County will disqualify the offer and evaluate the response of the next lowest-priced responsive offeror.

#### 25. Competitive Range and Best and Final Offer

Willacy County may determine that certain solicitation responses are within the competitive range and may use this range to award multiple Contracts. If the Willacy County elects to limit award consideration to a competitive range, the competitive range will consist of the solicitation responses that receive the highest or most satisfactory ratings, based on the published evaluation criteria and procedures governing this procurement. The Entity, in the interest of administrative efficiency, may place reasonable limits on the number of solicitation responses that will be included in the competitive range.

#### 26. Narrative and Company Information

Respondents must provide satisfactory evidence of its ability to manage and coordinate the types of activities described in this solicitation and to produce the specified services on time.
