Prior to award, the respondent must provide proof of registration, active/good standing and non-debarment status in the System for Award Management (SAM.gov) will be checked prior to award of the contract. If a respondent is not registered with SAM.gov, or the respondent is debarred, then the respondent's proposal will not be evaluated.

5. Governmental Entities
