(a) Perla M. Flores, M.S., Willacy County's Health Agent for Texas A&M AgriLife Extension Service/Healthy South Texas has been selected as the recipient of this year's "County Extension Agent – Specialty Award for Distinguished Program Achievement". She was nominated and chosen for this award due to the outstanding work that she has performed as the Health Agent in Willacy County. The County Extension Agent – Specialty Award for Distinguished Program Achievement recognizes educators who develop outstanding educational programs. In Texas, these are awarded annually by the Texas Extension Specialist Association (TESA) and the Texas A&M AgriLife Extension Service to agents who successfully collaborate with extension specialists. The award honors programs in five core categories:

- Agriculture and Natural Resources
- Family and Consumer Sciences (FCH)
- 4-H and Youth Development
- Community Development
- Specialty Area

Winners showcase high-impact educational programming delivered over the previous three years. Agents are celebrated at the annual TESA professional development conference.

A State Association reviews all nominees and typically selects just one winner per district or state in this category.
