Chairman Guerra, proceeds with the Budget Workshop. Discussion continues on reference to the Budget for the following:

Commissioner Henry De La Paz joins the meeting by Via Teleconference at 10:05 a.m.

County Auditor updates to the Court on the following requests:

- County Clerk's Office to keep one (1) of the positions that will not be funded from Record Archive to keep it under the County's Budget
- Justice of the Peace Precinct 1, proposed of the 5% salary increase and increase the part-time position 24 hours to 29 hours
- Elections Administration increase the part-time position from 20 hours to 29 hours
- Veteran's Officer, Frances Najera salary increase from \$18.00 hour to \$21.00 hour
- 5% salary increases for County Employees and County Elected Officials
- \$25,000.00 for Indigent Defense Director Priscilla Guajardo
- Commissioners Henry De La Paz and Mario Tijerina requested changes within their own budgets

Chairman Guerra, discusses on the following:

- Courthouse Restoration
- County/District Court Appointed Attorneys
- Hotel/Motel Tax Jessica Rodriguez be in charge of that budget and sign requisitions as a Department Head
- Hotel/Motel Tax is 80% Hotel/Motel Tax and 20% County. Chairman Guerra, proposes to be 50% Hotel/Motel Tax and 50% County (continue having the part-time position the way it is)
- Part-time position to full-time position for Maintenance needed for Trash Situation in Lasara, Texas and in Port Mansfield, Texas, to be fully funded from Health and Welfare

I.T. Technician:

Discussion on renewing the contract for Jesus Reyes Vazquez increasing from \$3,000.00 to \$3,500.00 per month.

Discussion continues with the Crime Victim's Assistance Program will no longer be 100% grant, now there will be a match.

Extension Agent's Office:

Extension Agent, Georgina Macias is requesting a salary increase for Cassandra. Court agrees to increase from \$13.58 hour to \$15.00 hour.

Tax Assessor/Collector's Office:

Tax Assessor Collector, Elizabeth Barnhart is requesting increases on CAD Contract with Appraisal District, Bonds, the mail postage machine, fees increase on their Software and a small increase on Account Number 385. An estimated increase amount of \$48,390.79 in her budget.

Sheriff Jose A. Salazar is requesting two (2) part-time positions for Dispatchers.

- Health and Welfare positions at the Commissioners Precincts for trash situation
- Meals at the Jail Department

District Attorney, Annette Hinojosa arrives at the meeting at 12:55 p.m.

Chairman Guerra, discusses with District Attorney, Annette Hinojosa about the Crime Victim's Assistance Program. Court agrees to include the County's Match for the Crime Victim's Assistance Program for District Attorney's Office and Sheriff's Department. Also, considering the 5% salary increases for County Employees and County Elected Officials.
