## Tax Assessor/Collector's Office:

Discussion continues the Tax Assessor/Collector's Office has collected about 92% on delinquent taxes.

Discussion continues with Chairman Guerra, stating that they would continue with Mandatory Requests.

County Auditor, Maria Del Carmen Maldonado states they need to budget \$7,200 for the County Judge Pro Tem. In addition, to budget \$3,600.00 for Commissioner Mario Tijerina for the Vector License and that Commissioner Ernesto Garcia had agreed not to renewal the Vector License.

Chairman Guerra, states they need to adjust Mandatory Amounts for example the meals and medical at the Jail Department. In addition, not considering salary increases, not making part-time positions to full-time positions, nor creating new positions for the next fiscal year.
