

**I. Introduction:**

**The Central Counting Station will be located at:**

Willacy County Elections Department  
190 N. 3<sup>rd</sup> St Rm 158  
Raymondville TX, 78580

- a. Elections Administrator:**  
Christina Rodriguez
- b. Senior Deputy Asst:**  
Joe Vasquez

**II. Roles and Responsibilities of Personnel:**

**a. Central Counting Station Manager:**

Will manage overall administration of office and supervision of personnel

**b. Presiding Judge:**

Will remain order at Central Counting Station and administer oaths. Receive ballot boxes.

**c. Tabulation Supervisor:**

Will operate the automatic tabulating equipment and run results reports on tabulator.

**d. Assistant Tabulator Supervisor:**

Will assist the Tabulator Supervisor

**e. Central Counting Station Clerks:**

Will count signatures on combination forms and compare them to the Ballot and seal certificate and get them ready for counting by the Tabulator Supervisor.

**III. General Rules of Conduct:**

- a. Follow the Rules and Regulations as per Texas Election Code.
- b. No electronic devices or cell phones are allowed in area, while ballots are being processed for counting.

**IV. Paper Ballots:**

- a. Scan Paper Ballots one at a time.
- b. Do any adjudication as necessary.
- c. Secure Ballots and all necessary items.

**V. Procedures For Verity Machines and End of Day Election:**

- a. After closing polls for Early Voting And Election Day Voting, Judges will bring back all voting machines to the Elections Department office At 190 N. 3<sup>rd</sup> St Rm 158 Raymondville Tx, 78580.
- b. Scans are to be secured at all times.
- c. All voting Judges will deliver voting machines to the tabulation Central Counting Station
- d. Central Counting Station Presiding Judge will remove seal from VDrive compartment and then secure Vdrives.
- e. Tabulator Supervisor will read in Vdrives from Early Voting and Election Night Count.
