- (a) It shall be unlawful for an owner or operator of a game room to operate, use or maintain, or to allow the operation, use or maintenance, of any room, building or facility in Willacy County as a game room under the definition provided in this regulation without first securing an official permit from the Willacy County Game Room Permit Administrator. A person who violates this regulation shall be assessed a civil penalty of \$10,000.00 per violation, with each day a violation occurs or continues to occur being considered a separate violation.
- (b) A completed application for a game room permit shall be filed with the Willacy County Sheriff. The application shall be filed on the form provided by the Sheriff or on an accurate and legible copy of that form. A copy of the application can be obtained at the Sheriff's Office. The applicant shall apply in person at the Sheriff's office

#### 2.2 Fee

Pursuant to Subsection 2.6 of the Regulations, there shall be levied and collected from an applicant for a game room permit an application fee of \$1,000.00 per application for initial permit or a renewal thereof, as authorized by Section 234.135 of the Local Government Code.

Payments are to be made by money order or cashier's check only. Please make all money order and cashier's checks payable to the Willacy County Treasury.

## 2.3 Incomplete Applications Shall NOT be Accepted

Pursuant to Subsection 2.1(b) of the Regulations, a completed application shall be filed with the Willacy County Sheriff on the form provided by the Sheriff or an accurate and legible copy of that form. Failure to provide all information required on the application shall be grounds for denial of the application.
